Product should be inspected and sorted before being accepted at any point during transportation. Develop and implement methods to check and document condition of product and packaging upon receipt at destination. Examine checks of time-temperature recording, indicating or integrator devices or, by prior arrangement with the shipper, test to determine if bacterial growth has occurred after the product was packaged and shipped. Include procedures for the safe handling and disposal of contaminated products. Identify where and how to separate contaminated products. Establish policy and procedures for rejection of packages and products that are not acceptable, can't be verified against the delivery roster, or contain unacceptable changes to shipping documents. Have a monitoring plan and record-keeping system in place to document steps taken. Do not accept products known to be, or suspected of being, adulterated.
